The purpose of this document is to form an Articulation Agreement between Concordia University Wisconsin (CUW) and Concordia University in Portland, Oregon (CUP) regarding the MEd Higher Education Administration program. The Articulation Agreement would serve the interests of students currently enrolled in the Higher Education Administration program who are seeking to transfer and enroll in **CUW's Masters of Science in Student Personnel Administration in Higher Education (SPAHE)**.

Due to CUP's closure, which is scheduled for the end of April, 2020, CUW is willing to enter into an agreement with CUP students, beginning with the Fall Semester (July 1, 2020), who want to enroll in the CUW SPAHE program with the following understanding and conditions:

- Students must meet the application requirements of CUW (an expedited application process will be deployed specially for CUP students).
- Students must complete the requirements of the SPAHE program (36 credits)
- Student transcripts will be reviewed to match courses to your CUW program.
- Students will be required to complete internship hours and a thesis or capstone.
- Students will be required to take a short Blackboard and online training module as established by CUW's Office of Distance and Continuing Education (OCDE) department.
- All credits earned in the CUP MEd programs will be eligible for transfer and application to the SPAHE requirements. Only courses with B grades or better will be accepted.
- Students transferring from CUP to CUW to obtain a Master's degree will not be eligible for licensure endorsement through CUW.
